Any products and or components repaired or replaced by RETENTION RANGE (PTY) LTD will be under warranty for the remaining period of warranty or for no less than 3 months. This warranty applies only to products that are new on the date of purchase from an authorized RETENTION product reseller. The Desktop product line is covered under a parts and labor repair or buffer exchange warranty for hardware, manufacturing, and/or power related issues, excluding power surges and/or electrical spikes.
